Board of Commissioners Regular Meeting Minutes
March 26, 2026

The Board of Commissioners of the Acadia St. Landry Hospital Service District met on Thursday, March 26, 2026 at 5:15 pm in the Acadia St. Landry Hospital Board Room at 810 South Broadway Street, Church Point, Louisiana.

CALL TO ORDER:

- The meeting was called to order by Chairman Lee Ward Bellard on March 26, 2026 at 5:25 pm.

PRAYER AND PLEDGE OF ALLEGIANCE:

- The Prayer was led by Rachel Broussard and Pledge of Allegiance was led by Lee Ward Bellard.

PUBLIC COMMENT:

- Chairman Lee Ward Bellard confirmed with those in attendance that there was no one with public comment. Being none, the public comment section was closed.

APPROVAL OF CONSENSUS AGENDA:

- Chairman Lee Ward Bellard asked if any items on the consensus agenda needed to be removed for further discussion. With no items to be removed, L. Bellard asked for a motion to approve the consensus agenda which contained the following items:

- Motion by Jeff Richard, second by Benji Bellard to approve all items on the consensus agenda. A vote was called, motion passed unanimously.

FINANCIAL REPORT:

- Jason LeBlanc, CPA with Lester, Miller & Wells, CPAs presented the financial reports and business office reports for the month of February 2026.
- Motion by R. Broussard, second by J. Richard to approve the February 2026 financial reports. A vote was called, motion passed unanimously.

Authorization for CEO to Enter into Contract for Hematology Analyzer Purchase

CEO Michael LeJeune stated that our current Hematology Analyzer would be “sunsetting” only June 31st at that we are in need of a new one. Lejeune gave the details of the hematology analyzer on behalf of interim lab manager S. Newsom.

- Motion by R. Broussard, second by Benji Bellard to allow the CEO to enter into contract to purchase a new Hematology Analyzer. A vote was called, motion passed unanimously.

Consideration of reappointment of Carrie Guidry, MD, nominated by the Medical Staff, to serve as Medical Staff Representative on the Board of Commissioners.

CEO Michael LeJeune stated that per the Louisiana Revised statues for Acadia St. Landry Hospital, we are required to have one active staff medical physician on the board. He further stated that the medical staff recommended Dr. Carrie E. Guidry for a second 2-year term on the board.

- Motion by R. Broussard, second by J. Richard to allow CEO Michael LeJeune to present Dr. Guidry to the Acadia Parish Police Jury for a second term. A vote was called, motion passed unanimously.

CEO REPORT:

In the way of the CEO report, LeJeune stated the following:

- Office of Public Health came to the hospital yesterday for their quarterly review of the kitchen. She stated there were not violations and the kitchen was “pristine”.
- I sent an email to all of the board members informing you that we have officially submitted our application to the USDA on Friday March 13th.
